DECISION ON PETITION
FOR
REINSTATEMENT

The Petitioner has filed a petition for reinstatement of his eligibility to practice before the Internal Revenue Service.

As permitted by Treasury Department Circular No. 230, the Director suspended the Petitioner for an indefinite period, effective June 15, 2007.

The Petitioner has represented to the Director that he is a Certified Public Accountant duly licensed by the West Virginia of Accountancy; therefore, but for the Petitioner's indefinite suspension, he is eligible to practice before the Internal Revenue Service. 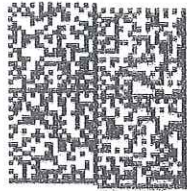

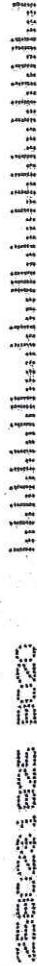
