Enclosed please a copy of an *Order Granting Default Judgment* entered on October 2, 2009, by the Honorable Judge Joseph Pomponio of the Greenbrier County Circuit Court. The *Order* grants the West Virginia Board of Accountancy ("Board") a permanent injunction against you from engaging in the practice of accountancy and the performance of attestation and compilation services. Should the Board learn that you are continuing in such practices, the Board will pursue contempt charges against you in court for failing to obey the Court's order along with the attorney's fees and costs associated with that proceeding. Please contact the Board office in order to become properly licensed to practice accountancy and the performance of attestation and compilation services.

Moreover, Judge Pomponio ordered that you pay to the Board attorney's fees and the costs of this litigation. You will receive within 30 days a bill from the Board office for the amount to be paid to the Board, and should you fail to pay these monies, the Board will pursue a contempt charge for your failure to pay.

## ORDER GRANTING DEFAULT JUDGMENT

The West Virginia Board of Accountancy, appeared by counsel, Katherine A. Campbell, Assistant Attorney General, and pursuant to Rule 55 of the West Virginia Rules of Civil Procedure, and to request this Court to enter a Default Judgment against the Defendant, Jeffrey S. Feamster. In support of such a request Plaintiff's counsel submitted a Motion for Default Judgment to this Court, and having considered the written arguments set forth in the Plaintiff's Motion for Default Judgment, the Court does hereby GRANT the Plaintiff's Motion for Default Judgment.

Therefore, the Court does hereby **ORDER** the Defendant permanently enjoined from engaging in the practice of accountancy and the performance of attestation and compilation services until such time as the Defendant may become properly licensed to do so by the Plaintiff. Further, the Court does hereby **ORDER** the Defendant to pay all reasonable attorney's fees and costs of this litigation, including, but not limited to investigative services and filing fees.
